**I declare that.**

- a) I am a registered breeder with the RNSWCC and the litter is / will be registered with the RNSWCC.(delete which does not apply)
- b) The puppies will not leave the premises before they are eight (8) weeks of age.
- c) The puppies will have had their required inoculation at the age of six weeks, and the certificate will be given to the purchaser.
- d) The puppies will be micro-chipped and I will complete the change of ownership and forwarded it to the appropriate body.
- e) The puppies will have been wormed on a regular basis – dates and details of worming preparation to be given to the purchaser.
- f) I will supply the purchaser(s) with details of the puppy's diet up to the date of purchase.
- g) All puppies will be sold in a state of good health.
- h) I will not knowingly misrepresent the characteristics of the Jack Russell Terrier.
- i) I shall ensure that all persons acquiring dogs from me clearly understand their responsibility for the care and welfare of the animal that they have the time & facilities (ie adequate fences sufficient room & proper shelter etc) to perform their obligations.
- j) I shall not sell any dog to commercial dog wholesalers or retail pet dealers who are not registered with the joint RNSWCC/PIJAC Australia Pet Shop Accreditation Scheme or directly or indirectly allow a dog to be given as a prize or donation in a contest of any kind.
- k) In addition to the above, I have complied with the RNSWCC regulations part XIII – code of Ethics and Part 1- the Register and Registration.

I understand that if I fail to comply with any of the above, the Jack Russell Terrier Club of NSW may refuse to accept any further application for litter listing from me, and disciplinary action may be taken.
